

Customs & security

- "YEMEN-Incident" discovery of parcel bombs being sent from
 Yemen to synagogues in the US in Oct. 2010
- Regulatory response at USA side : TSA requirements Nov 2010 heavily impacting posts and its customers
- Regulatory initiatives at EC side : EC regulation with strong operational impact on third (non-EU 27) countries -> need for dialogue ex-ante
- Link with customs : traditional info to and role of customs was for fiscal purposes. Move to new roles such as detection counterfeit/piracy and exchange platform for security advanced notice for possible pre-departure instructions such as do not load
- Assessment needed of the balance between free flow of goods and



Our Postal Specifics

- **USO** in the postal directive : availability & quality requirements
- **D** Postal supply chain :
 - not a "one-to-one" collect -> distribution chain
 - Post is mass medium & sorting processes
 - Presence of lots of unknown senders



- No institutionalized e-exchange of docs with customs authorities
- **UPU : simplified customs under UPU flagship (CN 22/CN 23)**
- UPU : freedom of transit. Issue in case of different regulatory rules in sending/transiting/receiving country
- **EU customs : UPU flows exempted for electronic advanced notice**

USA	 • TSA (Transportation and Safety Agency), created in the wake of 9/11 • Embedded in DHS (deparetment of Homeland Security) • Responsability for airport security + screening commercial airline passangers/bagage • Regulation via security directives & emergency directives • Examples : Nov 2011 piece level screening -> adapted March 2011 • ACAS : Air Cargo Advanced Screening pilot programme
Other continents/States	 Nation sovereignity & subsidiarity No harmonized approach : e.g. customs pre-alert for China

Aviation security

Basic Regulation 300/2008

- > Common one-stop security approach within EU
- > *Ratione personae* regulated: airports, operators, air carriers, other entities
- > Ratione materiae regulated : intra EU flights & outbound from EU
- > Differentiation mail from cargo
- > Concept of regulated agent, known consigner, screening methods, ...
- Principle : "All cargo and mail shall be subjected to security controls prior to being loaded on an aircraft. An air carrier shall not accept cargo or mail for carriage on an aircraft unless it has applied such controls itself or their application has been confirmed and accounted for by a regulated agent, a known consignor or an account consignor"
- > Details via supplementing & implementing regulations. exemptions via restricted Commission Decision(s).



Aviation security

August 2011 : new regulatory package via Regulation 589/2011 & implementing Decision

- > Common one-stop security approach within EU
- > Principle of "High Risk Cargo and Mail" : strengthened screening
- > New strict rules on inbound traffic to EU from third countries (ACC3 designation)
- > Two stage approach for third countries: ICAO screening standards until July 2014 -> thereafter EU standards to be applied by third countries + independant validators from the EU






Example of EU Inbound supply chain





Example of new EU inbound requirements






Customs

- Community Customs Code : directive of 1992 (numerous updates) & Implementing Provisions via Commission regulation 1993 (numerous updates)
- "Security amendment": Commission regulation 648/2005 (Annex 30 A details): as of 1 Jan 2011 pre-arrival & pre-departure information via entry/exit summary declarations in ICS/ECS. Letters, postcards, printed matter + goods moved under the rules of the UPU excluded
- **Given Signal to review existing Customs derogation procedures**
- Dialogue PostEurop DG TAXUD ongoing + interim group started at UPU











Dialogue welcomed and appreciated

- Aviation security: postal operators and their customers directly affected and indirectly via approach adopted by airlines
- Customs : postal operations not built in context of (electronic) advanced notice. Need for dialogue towards future approach and agreed timeline
- Assessment needed of balance between free flow of goods and data & security
- □ And... worldwide approach/standards needed
